I found house bets document to be sufficient however the only caveat I see (post case and with hindsight) is the question you raised as to whether or not the "10 days instead of a 7 day calculation" has merit or not, why? because it leaves me wondering one thing specifically. Did it only apply to you or to others as well? If it happened to everyone it doesn't make a difference, if it happened to only you then it makes a significant difference in my opinion. If it was everyone, similar to that of say a monthly bonus on stake, it's not always on the same time sometimes they push it out late and it could be a blessing for some or a curse for others depending on where they end up in the profit and loss by the new date (casinos factor loss heavily) and yes they reserve discretion to change it as bonuses are not contractual obligations but rather discretionary promotional bonuses.

I think it is a lot of speculation here as to if you're owed money or not on your part it seems more like a question of compensation for theoretical amounts and litigating terms, or FAQs and support interactions as contractually binding.

If you truly mean that you want to bring house bets to justice for the community, I can understand your angle but, if this is to pursue personal result in terms of monetary gains, I don't think you will prevail.

2 - Weekly / Lossback calculation

Lossback refunds part of a *net loss* over a period; it pays only if the period ends down. His weekly slider was **100% lossback / 0% rakeback** from 23 Apr (Appendix C).

For the week containing his 25 May session, the **certified daily record** (Appendix B) shows he finished **net up**:

Weekly window	His net result
18-28 May (the cycle applied)	LIP +\$48,990
21-27 May (Thu-Thu alternative)	LIP +\$28,657

With no net loss, weekly lossback correctly settled to -\$0 for that cycle. In earlier weeks where he was net down, weekly lossback was paid — part of his \$51,431 in total rewards (Appendix D). The engine's weekly settlement for the period independently reconciles to the cent. **\$0 is correct — he won that week**

There are two different figures in the document, and they do not agree with each other.

From the transaction totals in the appendices:

- Total Deposits: \$690,354 (Appendix B total)
- Total Withdrawals: \$729,757.44 (Appendix A total)

Based on those totals:

$\$729,757.44 - \$690,354.00 = +\$39,403.44$

So, according to the appendix totals, DrWgamba is up \$39,403.44 on a deposits-versus-withdrawals basis.

However, there is an inconsistency

Earlier in the report, the summary states:

"Across all activity his withdrawals exceeded his deposits by about \$28,334."

That statement does not reconcile with the appendix totals.

So the document contains an internal discrepancy:

Based strictly on the detailed deposit and withdrawal figures provided in the document, the net is +\$39,403.44, not +\$28,334.

- Whoever wrote the report's narrative added the USDT and TRX blocks together at face value → deposits looked like \$701,423 → "withdrawals exceeded deposits by about \$28,334." We know this is exactly what happened because the mistake reproduces the published figure to the cent (\$28,334.11).

- The appendix, meanwhile, was built from the daily activity record, which properly converts TRX to dollars → deposits \$690,354 → net = +\$39,403.

Elder's example is correct: lossback resets by period.

Also, Porchy now admits the initial report mixed up TRX and inflated numbers. That proves exactly why I asked for backend records instead of trusting a PDF summary.

So let's keep it simple:

Show the real cycle records.

If 18–28 May existed before my loss, the records prove it.

If they cannot show them, then the \$0 weekly conclusion is not proven.

If I lost in that week, with 100% Lossback active, pay what you advertised or show the record proving why not.

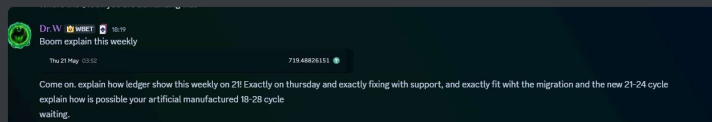

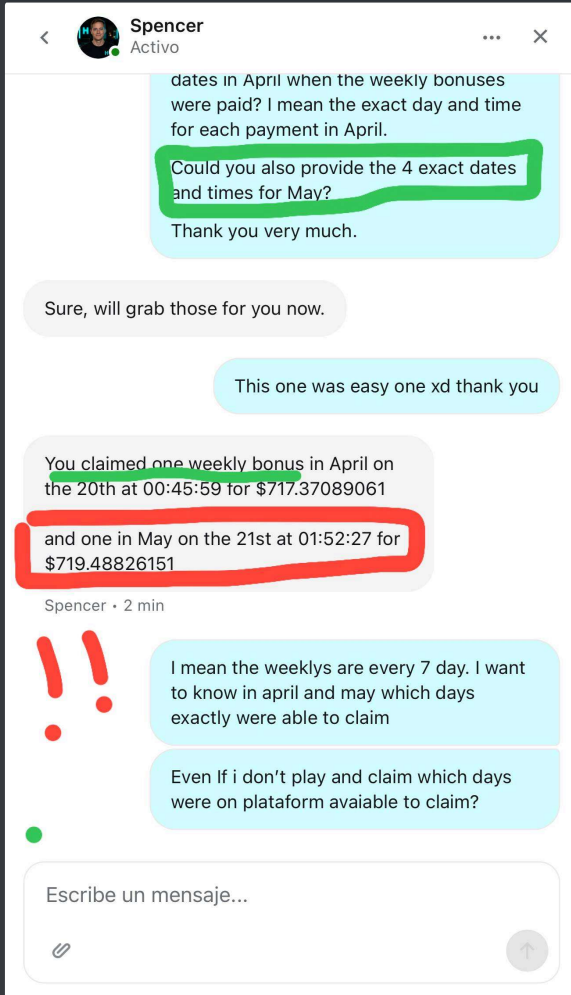

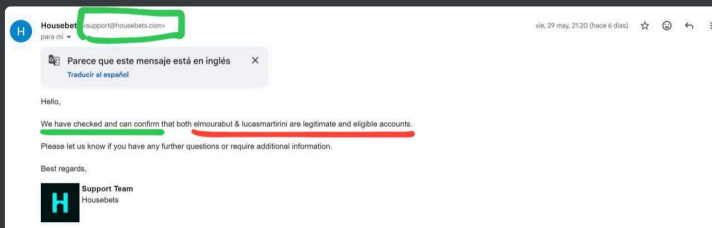

So they put fake accounts on the leaderboard so they wouldn't have to pay it out and could win it themselves. Those accounts pressured the player in first place, which was me. I ended up losing \$100k because I played more under that pressure to try to win the leaderboard. On top of that, those accounts were wagering through categories that were later changed because they had been hidden.

A casino allegedly tries to use fake accounts to avoid paying leaderboard prizes while creating pressure that makes real players wager more and lose more.

If the player doesn't realize what's happening, they don't win the leaderboard, they don't receive the prizes, and they end up losing even more because of the pressure of fighting for first place. That's exactly what happened in my case.

First of all, we should be condemning the casino for that. Somehow, everyone seems to be glossing over it.

Second, if the player catches them, sends an email, and the casino officially replies that everything is fine, that the accounts are legitimate, and tells the player to keep playing because there's nothing wrong, then the player loses \$100,000. Later it turns out the accounts were not legitimate after all, and they get deleted. Whose fault is that? The player's?

Or should the casino be held responsible for officially telling me those accounts were legitimate after supposedly checking them multiple times, causing me to keep playing?

And the best part? After the casino does all of that, I'm apparently supposed to thank them for eventually deleting the fake accounts that cost me money and then giving me the leaderboard.

Let me remind you: without those fake accounts, the leaderboard was already mine. The only difference is that I wouldn't have lost that \$100,000.

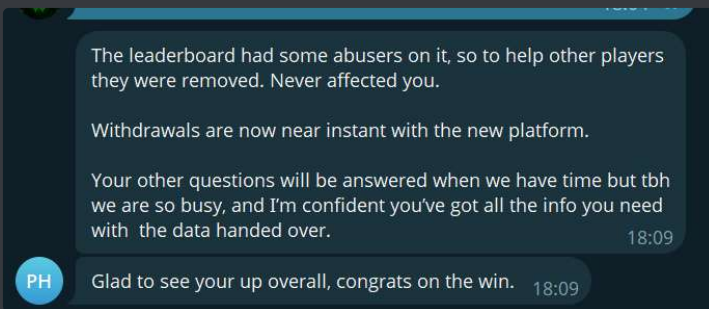
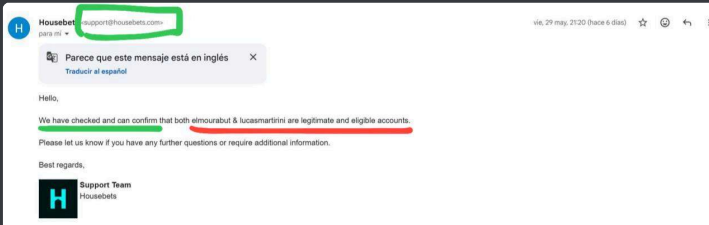

You make a fair point. The hardest part here is there's no way to directly associate the money you deposited/wagered with changing the leaderboard prize. At the end of the day it was still legitimate and regular play, and let's say you had won with the money you would've been paid out.

It is definitely unfair pressure from the casino though, depending entirely if the accounts were orchestrated on behalf of Housebets or actual abusers. I run a casino, albeit on a much smaller scale, and we regularly deal with eliminating players from leaderboards who wager abused (eg through 1.01x spam)

Considering Housebets verified that the players were legitimate (meaning they manually checked the play history) that does give them some responsibility in this case. It can be up to anyone's discretion whether the intention of your play was for the leaderboard, but they indirectly encouraged that you continue play against these accounts that they now deemed as valid opponents.

Regardless I think at least some compensation is justified, but I don't see fit that anywhere near the \$100,000 figure you suggested is reasonable.

As for the \$100k figure, I mentioned that because it reflects what I lost during that specific window of a few hours. The exact amount is something that could be discussed; I don't have a problem with that. What matters is that their responsibility is undeniable.

And there's another important point: by officially confirming those accounts were legitimate, they actually made the situation even more suspicious. It raises the possibility that they were trying to hide the fact that the accounts belonged to them, which is why they chose to validate them instead of investigating or removing them.

Weekly Bonus

Housebets claims there was a special bonus cycle running from **May 18 to May 28**, and they rely on that single cycle to justify not paying my weekly bonus.

However, here's what Support themselves confirmed through multiple agents:

- I claimed a **\$719 weekly bonus on May 21**, and I have it recorded in my ledger.
- They confirmed that, because of the migration, the next weekly covered **May 21 to May 24**, which perfectly matches the Weekly Leaderboard that ran from **May 25 to June 1**.
- They also confirmed that I claimed that **May 21–24 weekly** in the early hours of **May 25**.

So how is it possible that every confirmed weekly cycle lines up with the evidence **except** for this

alleged **May 18–28** cycle?

If that 10-day cycle really existed, how can there simultaneously be **two separate weekly cycles** entirely contained within it? It simply doesn't make sense.

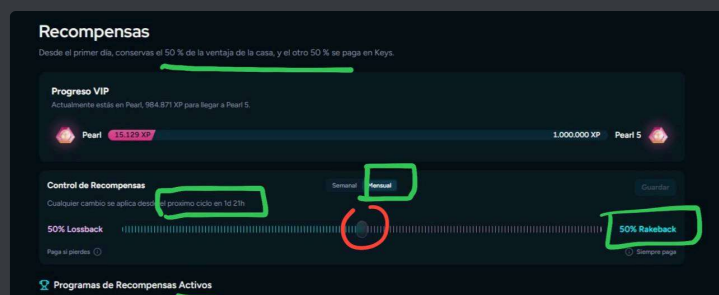
Monthly Bonus

They claim they didn't pay me the full amount because my slider was set to **100% losses**, and if that were actually true, they'd have a valid point.

However, throughout the entire month, the UI showed the slider set to **50/50**, as you can see from this evidence taken **just one day before the monthly bonus was paid**.

So, based on that, it's reasonable that I wouldn't receive the **50% allocated to losses**, but I **should** receive the **50% allocated to wager** for the entire month.

Given that I wagered approximately **\$4 million** during that month, shouldn't I be paid the wager-based 50% for the full monthly period?



It's all completely insane. The whole thing is built on lies, and I have the evidence to back it up. The problem is that nobody has actually taken the time to ask them the right questions or properly examine the evidence, whether because of some hidden interest or simply a lack of interest.

The structure is actually very simple. You have a slider that you can set however you want for both the weekly and monthly bonuses.

You can choose 100% losses, 100% wager, or a 50/50 split for both the weekly and the monthly bonus. I had my weekly bonus set to 100% losses and my monthly bonus set to a 50/50 split.

What does that mean? For the weekly bonus, if I was down during that week, the entire bonus was calculated based on my losses. For the monthly bonus, since I finished the month in overall profit (I'm talking about the whole month, not the weekly results), I wouldn't receive the 50% loss-based portion, but I should still receive the 50% wager-based portion.

As for the bonus cycles, it's very simple. You just look at the ledger and the support responses, there's nothing else to it. It's already been verified, and I've uploaded the evidence.

The so-called 18–28 cycle is a made-up 10-day cycle used to claim that's how the weekly bonus worked. It directly contradicts their own support team and their own weekly bonus payments on the

21st and the 25th. The only purpose of that claim is to make it look like I didn't have weekly losses so they can avoid paying me.

I trusted Housebets. I kept playing. While those accounts kept pressuring the race, I lost another \$91k.

Later, Housebets admitted those same accounts were linked, flagged and zeroed.

So what exactly did you review before telling me they were legitimate?

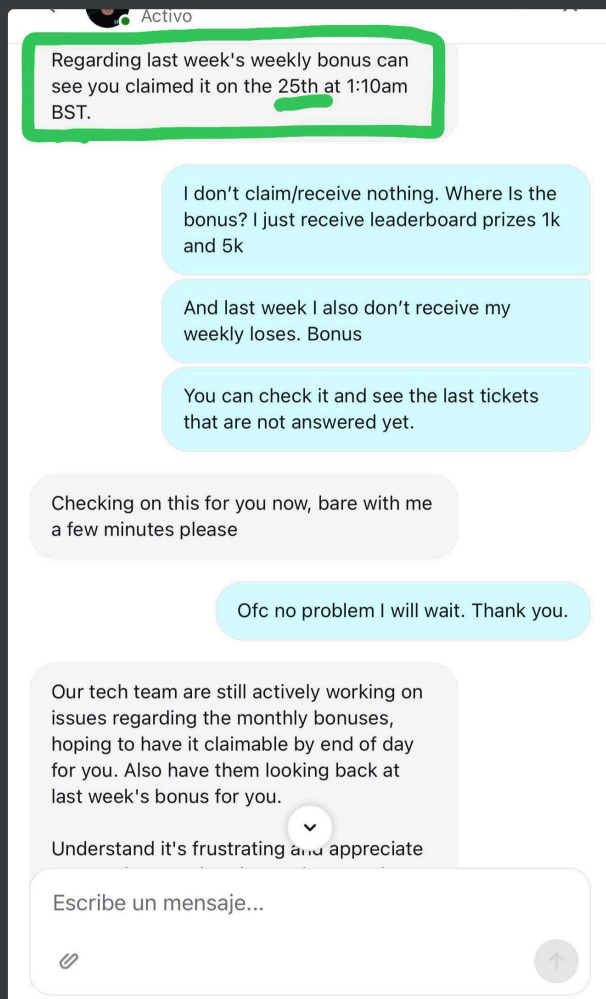
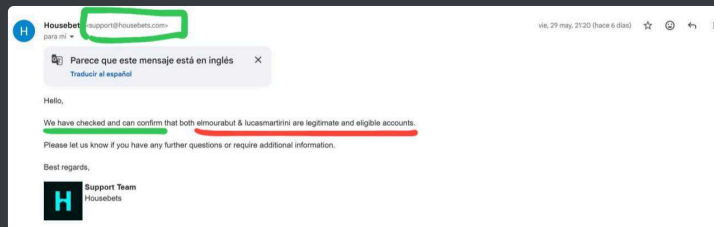
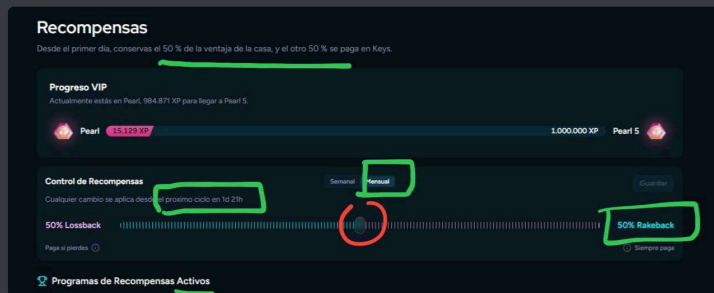
