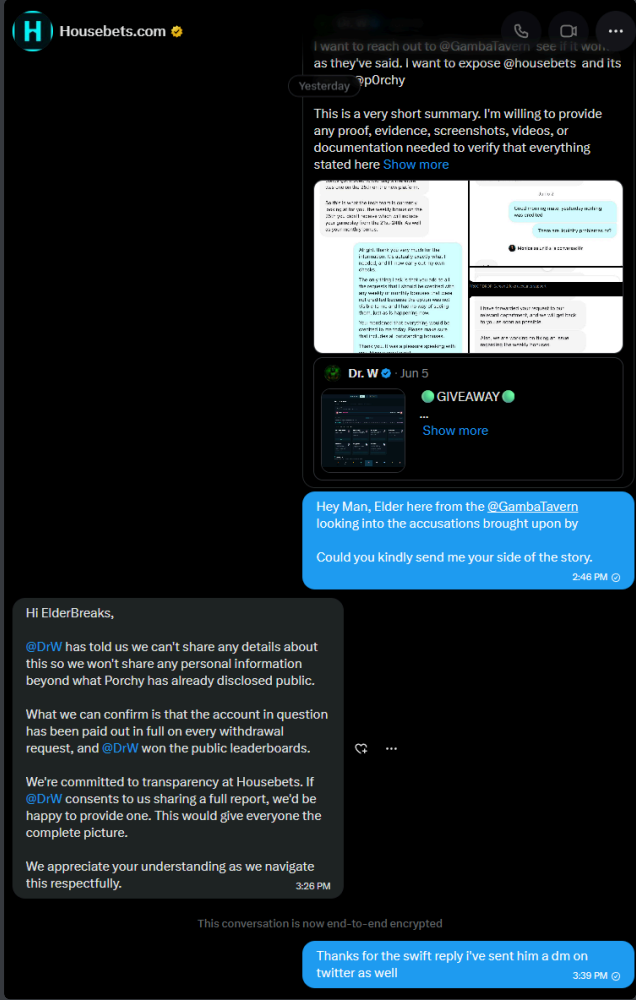



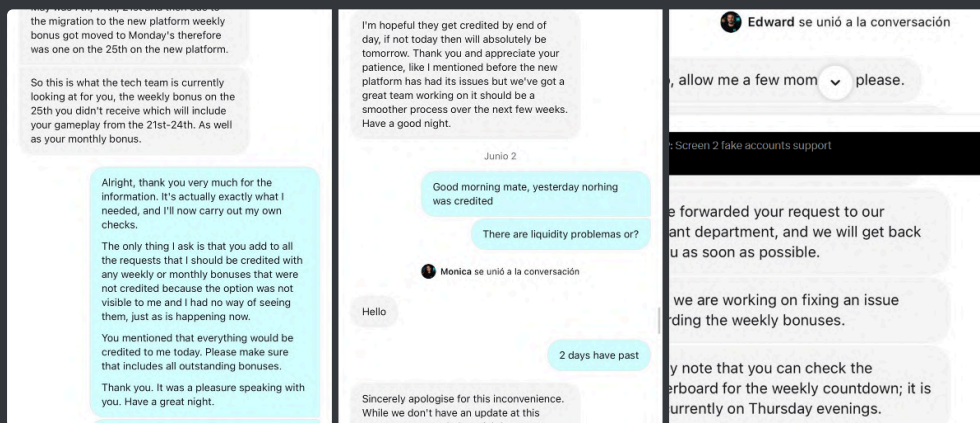

Yes, exactly. The issue for me is not "Housebets can't send anything".

They can send anything that is relevant to the accusations I am making in this case (the shared post). I actually want them to do that.

What I don't want is irrelevant private data, personal information, full account dumps, or unrelated material being sent to confuse the issue or shift the focus away from the actual dispute.

For this case, the relevant records are things like:

- Weekly/Lossback calculation;
- May Monthly Bonus calculation;
- ledger entries for those rewards;
- GGR/NGR used in the calculations;
- slider history;
- weekly/monthly cycle timestamps;
- leaderboard snapshots;
- eligibility/funding records for elmourabut and lucasmartirini;
- game/category mapping records;
- explanation of whether categories, game labels or leaderboard contribution rules changed.

That is all relevant.

What is not relevant is KYC, IPs, device data, private personal details, unrelated account notes, unrelated gameplay history, or a full private account report used to bury the actual questions.

If some wallet or transaction data is genuinely needed to verify a point, then it can be redacted or provided privately to an independent reviewer. I'm not trying to hide evidence.

I'm simply saying: keep it relevant to the accusations, redact private identifiers, and answer the case point by point.

To be clear, I have no issue with Housebets providing relevant account information if it helps verify the facts.

For example, I have no problem with deposit history, withdrawal history, dates, amounts, bonus history, reward history, ledger entries, wagering records or anything else directly related to the accusations being discussed.

My concern is not transparency.

My concern is relevance.

If a piece of information helps verify whether the Weekly/Lossback was paid, whether the Monthly Bonus was paid, whether the leaderboard calculations were correct, or whether the disputed accounts were genuinely eligible, then I have no problem with it being reviewed.

What I don't want is unrelated personal information, private identifiers, KYC documents, IPs, device fingerprints, wallet ownership information, or a massive account dump containing material that has nothing to do with the dispute and only serves to distract from the actual questions.

So my position is simple:

Anything relevant to the allegations = absolutely fine.

Anything unrelated to the allegations = should be redacted or excluded.

I'm not trying to limit evidence.

I'm trying to keep the case focused.

The only thing I ask is exactly what you said: please keep it focused on the relevant points I mentioned.

If Housebets provides calculations, ledgers, dates, deposits/withdrawals, bonus history, slider history, leaderboard snapshots, account eligibility/funding records, game/category mapping or anything directly connected to the accusations, I have no issue with that.

If they provide something formal about my account, I also ask that it is sent to me as well, because this is already being handled through formal channels by email too. I commit to sharing here anything relevant that they send me, so everyone can compare it and verify it.

What I don't want is unrelated private data or a huge account dump used to distract from the actual questions.

So yes, please reach out to them. I appreciate you doing it this way.

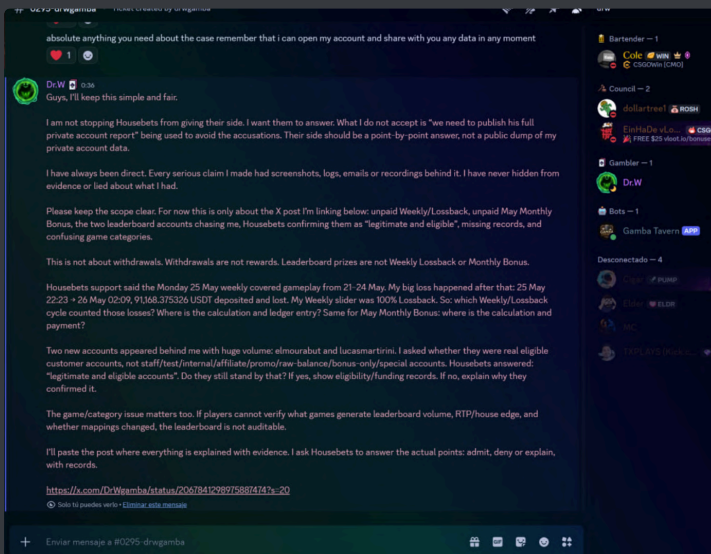

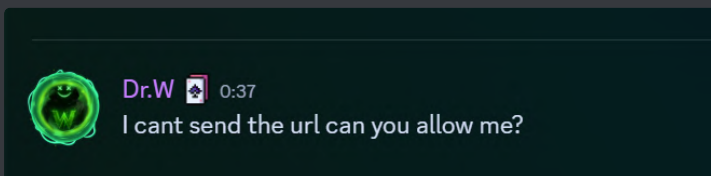

Guys, I'll keep this simple and fair.

I am not stopping Housebets from giving their side. I want them to answer. What I do not accept is "we need to publish his full private account report" being used to avoid the accusations. Their side should be a point-by-point answer, not a public dump of my private account data.

I have always been direct. Every serious claim I made had screenshots, logs, emails or recordings behind it. I have never hidden from evidence or lied about what I had.

Please keep the scope clear. For now this is only about the X post I'm linking below: unpaid Weekly/Lossback, unpaid May Monthly Bonus, the two leaderboard accounts chasing me, Housebets confirming them as "legitimate and eligible", missing records, and confusing game categories.

This is not about withdrawals. Withdrawals are not rewards. Leaderboard prizes are not Weekly Lossback or Monthly Bonus.

Housebets support said the Monday 25 May weekly covered gameplay from 21-24 May. My big loss happened after that: 25 May 22:23 → 26 May 02:09, 91,168.375326 USDT deposited and lost. My Weekly slider was 100% Lossback. So: which Weekly/Lossback cycle counted those losses? Where is the calculation and ledger entry? Same for May Monthly Bonus: where is the calculation and payment?

Two new accounts appeared behind me with huge volume: elmourabut and lucasmartirini. I asked whether they were real eligible customer accounts, not staff/test/internal/affiliate/promo/raw-balance/bonus-only/special accounts. Housebets answered: "legitimate and eligible accounts". Do they still stand by that? If yes, show eligibility/funding records. If no, explain why they confirmed it.

The game/category issue matters too. If players cannot verify what games generate leaderboard volume, RTP/house edge, and whether mappings changed, the leaderboard is not auditable.

I'll paste the post where everything is explained with evidence. I ask Housebets to answer the actual points: admit, deny or explain, with records.



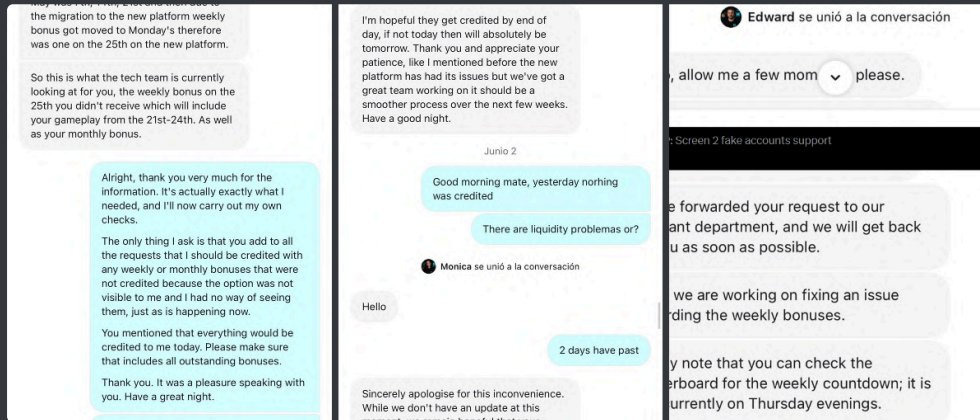



Before anything else, I need to flag something serious.

This has already started exactly in the direction I warned about.

Porchy was invited here to answer the allegations in the X post. Before answering a single point, his first move was to ask for permission to share "all account details", post part of a private Telegram conversation from before this Council channel existed, and disclose my legal name / personal identity without my consent.

I am not saying this to play victim. I am saying it because it proves the concern was real.

If this is how it starts, imagine giving open permission for him to publish whatever he has prepared, without scope, without redactions and without first answering the actual allegations.

I use DrW publicly. My legal identity is not relevant to whether Housebets paid Weekly/Lossback, May Monthly Bonus, or whether the leaderboard accounts were genuinely eligible.

So I ask the Council to please redact/remove any personal identifying information and make clear that personal identifiers should not be used here again. I have preserved what happened and will deal with that separately through the appropriate channels.

Now, to be very clear:

I am not saying Housebets cannot share evidence.

I am saying Housebets should share evidence that is relevant to the accepted scope of this ticket: the X post I linked.

That means I have no issue with relevant account data such as deposits, withdrawals, dates, amounts, wagers, ledger entries, rewards, bonus history, slider history, GGR/NGR, cycle timestamps, leaderboard snapshots, eligibility/funding records and game/category mapping.

What I do not consent to is “all account details”, a full account dump, unrelated private information, KYC, IPs, device data, wallet ownership info, unrelated Telegram conversations, unrelated gameplay, internal notes, or personal identifiers.

I am not hiding evidence. I am asking for relevance.

As the case progresses, if any information becomes necessary regarding what has actually been alleged in the post and accepted for review here, I have no problem providing it myself.

But first we need Porchy / Housebets to answer the allegations and explain their version, so we can identify exactly where our versions differ and what evidence is actually needed.

Whatever is necessary at that stage, as long as it respects my privacy and stays relevant to this dispute, I commit to providing it. And if there is something I do not have, I will ask Porchy for it here in front of everyone so he can provide it too, if the Council agrees.

For this ticket, I only ask that we keep the focus where it belongs: on the Housebets allegations in the X post.

But please do not use legal threats as a shield to avoid answering the Council.

You can provide any relevant records needed to answer the post. So let’s start simple:

- 1) Are you answering here on behalf of Housebets?
- 2) Did Housebets support tell me that the Monday 25 May weekly covered gameplay from 21–24 May?
- 3) My major loss happened after that period: 25 May 22:23 → 26 May 02:09, 91,168.375326 USDT deposited and lost. Which Weekly/Lossback cycle counted those losses?
- 4) Was my Weekly slider set to 100% Lossback at the relevant time? If yes, where is the calculation and ledger entry? If no, show the slider history.
- 5) Was the May Monthly Bonus calculated and paid separately from leaderboard payments? If yes, show the separate calculation and ledger entry.
- 6) Do you still stand by Housebets’ email confirming elmourabut and lucasmartirini as “legitimate and eligible accounts”?
- 7) Were those accounts funded only with normal real-money customer deposits, or did they have any staff, test, internal, affiliate, promo, raw-balance, creator-deal, bonus-only or special account setup?
- 8) Did game/category labels, mappings or leaderboard contribution rules change during or after the dispute?

Legal threats, jokes about “no crying in the casino”, private Telegram screenshots and comments about my identity do not answer any of these points.



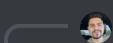

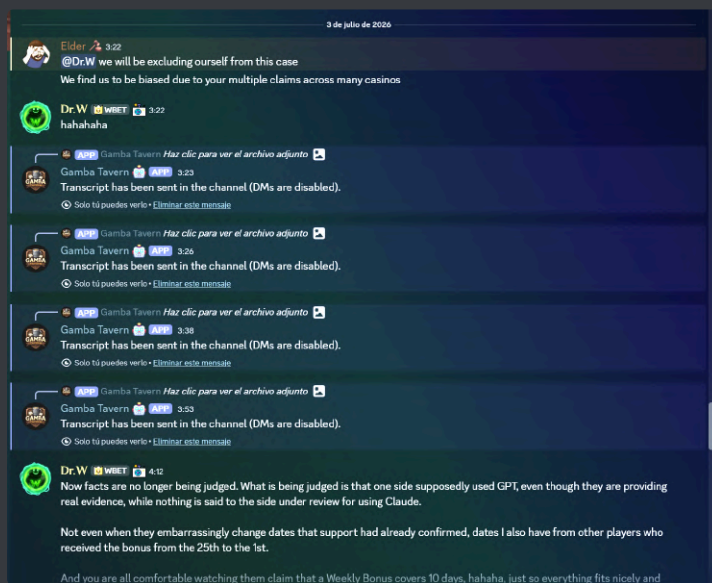

Housebets says my Weekly/Lossback was correctly paid at \$0.

Problem: the UI doesn't lie and shows Monthly 50/50 active during May, where you can clearly see that 1d21h was left with this configuration, and support first talked about a Monthly Bonus "claimed" and then said tech was working to make it claimable. Housebets, your lies are starting to pile up...



## 3 LEADERBOARD / FAKE ACCOUNTS THAT PRESSURED THE RACE

I was first on the leaderboard and two accounts appeared, elmourabut and lucasmartirini, with massive wager pressuring the race.

I complained and Housebets confirmed to me through support/email that they had already reviewed everything and that they were "legitimate and eligible" accounts, and that I should keep playing.

\*REALITY/EVIDENCE:

When I pushed about the fake categories, the mapping, and the eligibility, Housebets admitted that those accounts were linked to each other, flagged for bonus/lossback abuse, and zeroed on the leaderboard. They disappeared.

Problem: those accounts were visible and pressuring while I kept playing. Even if they were zeroed afterwards, the live pressure had already happened. They tried to scam the top positions, but I caught them and they had to backtrack.

Also, their volume appeared under changed categories and different games, which made it hard to audit what games they were using, how they counted for the leaderboard, and whether they were really legitimate competitors.

What I am saying is that Housebets' theory of the 18–28 May cycle does not fit with their own data or their own support.

As far as documented, the weekly bonuses were 7-day cycles and were claimed on Thursdays. 21 May was a Thursday, support confirms that this weekly was claimed, and it also matches the \$719 payment and the ledger/screenshot from that same day.

With that alone, the 18–28 May cycle already breaks.

A weekly cycle from 18–28 May cannot exist if inside that supposed cycle I already claimed a normal weekly on 21 May.

Then came the migration to the new Housebets / Housebets 2.0. Because of that migration, support explained that the 25 May weekly covered the period 21–24 May. That also matches my version: the short migration cycle ended there, and the next weekly cycle started on 25 May and ended on 1 June.

In fact, Housebets' own PDF uses 25 May → 1 June as the weekly period for the Weekly Leaderboard, which I also won and was paid on 1 June.

That is why my complaint was never that the leaderboard was not paid or that withdrawals did not arrive. That is mixing topics.

My complaint is that I was not paid the Weekly/Lossback corresponding to the 25 May → 1 June cycle.

And my loss happened inside that new cycle:

25 May 22:23 → 26 May 02:09  
91,168.375326 USDT deposited/lost.

After that loss, I did not deposit any more money that could change the result of that weekly. That week should have ended in loss, and my Weekly slider was at 100% Lossback, something Housebets also recognizes in its own PDF.

So the question is not complicated:

Why is Housebets now using 18–28 May to deny the Lossback, if the normal weekly on the 21st was already claimed, support said the migration cycle was 21–24, and their own PDF uses 25 May → 1 June as the weekly leaderboard period?

The answer seems clear: by using 18–28 May, they include previous days to offset my 25–26 loss and turn a negative weekly into a supposed positive result.

That is exactly what they have to prove with official records:

- cycle ID for 18–28 May;
- cycle ID for 25 May → 1 June;
- Weekly/Lossback settlement record;
- formula used;

- GGR/NGR;
- ledger of the payment or zero-settlement.

Without that, the \$0 is not proven.

And the Monthly is another separate point.

Housebets says that the May Monthly was at 0% Rakeback / 100% Lossback, which is convenient for them because since the full month ended positive, they would pay \$0.

But the UI showed Monthly 50/50 during May, with the cycle active and time remaining. That means that, even if the 50% Lossback could be \$0 because the month ended positive, the other 50% Rakeback/Wager still had to be calculated based on the month's volume, and that month had around 4M wager.

That is why they also have to show:

- slider audit trail;
- UI/terms explaining why the visible 50/50 did not apply to May;
- May Monthly Bonus calculation;
- settlement or zero-settlement record.

In summary:

Housebets cannot have a normal weekly on the 21st, a migration cycle 21–24, a weekly leaderboard 25–1, and then use 18–28 to deny the Lossback.

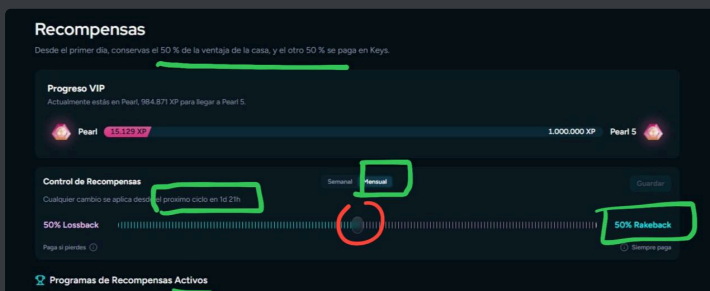

I found house bets document to be sufficient however the only caveat I see (post case and with hindsight) is the question you raised as to whether or not the "10 days instead of a 7 day calculation" has merit or not, why? because it leaves me wondering one thing specifically. Did it only apply to you or to others as well? If it happened to everyone it doesn't make a difference, if it happened to only you then it makes a significant difference in my opinion. If it was everyone, similar to that of say a monthly bonus on stake, it's not always on the same time sometimes they push it out late and If could be a blessing for some or a curse for others depending on where they end up in the profit and loss by the new date (casinos factor loss heavily) and yes they reserve discretion to change it as bonuses are not contractual obligations but rather discretionary promotional bonuses.

Okay, I think this is where our positions start to become similar, not identical, because I understand what you're saying and I respect it.

But from my point of view, as a player who genuinely feels he was misled (because I don't believe this was just a mistake, considering they reassured me twice that everything was fine, and the games those accounts were playing were actually hidden, I'll send you screenshots if you want), I believe there was bad faith involved. That's why I think the fair outcome would be to compensate me for the losses that happened because of their actions and the pressure they allowed to happen. They had two opportunities to investigate it, and both times they confirmed everything was fine. That's the minimum responsibility they should have in a situation like this.

At the same time, I also understand that there is a hypothetical world where this was genuinely their mistake. They even said they were going to compensate me for it, but they still haven't. I'd be willing to accept that compensation, as long as it's not just an insult and it's paid together with the two bonuses they still owe me.

Regarding the weekly and monthly bonuses, I'm genuinely glad you agree with me. I think if Porchy actually answers the questions I've sent him, he's going to corner himself. The evidence, no matter how anyone tries to spin it, is overwhelming.

We're not talking about some PDF they produced afterwards. I'm talking about conversations with Support that I downloaded in full from their own website. In other words, it's the casino itself that gave one version of the facts and is now trying to deny it. We have clear UI evidence and the ledger.

Those things can't be faked. The fact that I received the weekly bonus on the 21st for \$719 cannot be hidden, and Support themselves confirmed it.

And if that single fact is true, then the made-up cycle from the 18th to the 28th immediately falls apart, because if there was already a weekly payment on the 21st, then there simply cannot have been another weekly cycle running from the 18th to the 28th. That's why I'm genuinely happy that you've actually taken the time to read everything, understand it, and reach the same conclusion as me on this point.

We've clashed a few times, and if my tone hasn't always been the best, I apologise. But what has happened to me, with people not reading the evidence, closing the case without understanding it, and dismissing it, has been incredibly frustrating. It's especially painful when you know you're right.


So, as the first member of the council who's actually willing to engage with the evidence, I genuinely appreciate it.


I'm still completely open to providing whatever else is needed, or even giving access to my account if that's necessary for any further review.

But in this case it's even more serious, because it wasn't something they promised specifically to me

or some personalized deal. These are the platform's standard rewards, the bonuses that every user is supposed to have.

To give you an example so it's easier to understand: it's not like I had some special privilege. It's like if I joined Empire's affiliate program with the exact same commission percentage as everyone else, and then, once I met the requirements, they simply refused to pay me.

Just to be clear, these are the site's official terms for every player and they're a core part how they market the platform. It's not a verbal agreement or some private written deal. When you sign up, there's literally a slider in your account that you set yourself.

I think that makes it a lot more serious. That said, I completely understand your situation. If I can help or make some noise so people know what happened, send me the evidence and I'll do it.


A lot of people seem to think I make a living "scamming casinos," but it's actually the complete opposite. I've never received a lawsuit from any casino, while I've sent several myself. The difference is that I gamble with real money, unlike many others, and when you play with real money, things like this happen—as you already know.


The only difference is that I refuse to stay quiet. And if one casino scams you, then another, then another, people start treating you as if you're the common denominator without ever looking at the evidence. But I guarantee you that if people spent just ten minutes reviewing the evidence behind any of the cases I've made public, they'd be genuinely surprised.

Well, let's just say I haven't played all my cards regarding the leaderboard yet. I'm waiting for him to say something that's false so it backfires on him. My devs helped me uncover some additional evidence by tracing transactions.

So I think I'm in a position to go all in. I'm not going to give anything away for free.

We'll see what attitude Porchy comes back with tomorrow—whether he's interested in resolving this or if he's looking for a fight.
